time if needed. Having the plan in place is required for federal Emergency Funding eligibility. The plan has been approved by the State and Federal Agencies of Emergency Management, and now is presented to the local entities for adoption. Commissioner Huizenga moved and Commissioner Mehlhaff seconded to approve Resolution 2597 adopting the Plan. Unanimous approval.

Resolution 2597 to adopt the 2016 Hughes/Stanley Counties Multi-Hazard Mitigation Plan

Whereas, the City of Pierre recognizes the threat that natural, man-made or technological hazards and threats pose to people and property within our community; and

Whereas, undertaking the hazard mitigation actions will reduce and/or eliminate the potential for harm to people and property from future hazard and threat occurrences; and

Whereas, an adopted Multi-Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under multiple Federal Emergency Management Agency (FEMA) pre- and post-disaster mitigation grant programs; and

Whereas, the City of Pierre participated in the preparation of this plan in accordance with the Disaster Mitigation Act of 2000; and

Whereas, adoption of the 2016 Hughes/Stanley Counties, South Dakota, Multi-Hazard Mitigation Plan demonstrates the commitment to hazard mitigation; and

Now, therefore, be it resolved, that the City of Pierre adopts the 2016 Hughes/Stanley Counties, South Dakota, Multi-Hazard Mitigation Plan.

Let it be known that the soils underlying the City of Pierre may be problematic and can be a hazard to structures and infrastructure. The Multi-Hazard Mitigation Plan is not intended to be an authoritative document on this issue. Data is available from the City of Pierre Engineering and Planning Department.
